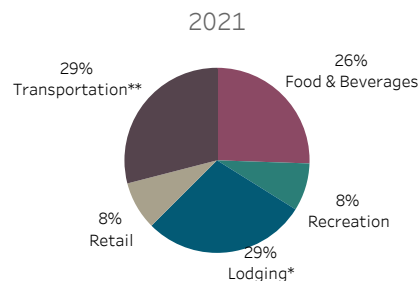
## VISITOR SPENDING OVER TIME

Values represent the direct impact of spending, labor income, employment, and taxes for both domestic and international travel.

In the transition to Tourism Economics, all counties have experienced an adjustment in overall impact and/or ranking.

## IMPACT PER DAY

On an average day in 2021, visitor spending in Jefferson County generated:

**\$170,647** in daily expenditures

**\$32,944** in daily labor income

**\$7,435** in daily state taxes

**\$5,730** in daily local taxes

## IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Jefferson county, each household pays:

**\$240** less in state and local taxes

**\$135** less in state taxes

**\$104** less in local taxes

## IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Jefferson County household would pay **\$240** more in state and local taxes.

## RANKING

In 2021, Jefferson County ranked  
**31**  
of 95 counties in visitor spending,  
compared to 30 in 2020.
